

International Shipment & Customs Regulations and Information

Czech Republic

It is extremely important that you take a few moments to review these important requirements, as they will allow us to process the release of your personal property through foreign customs. Customs processing varies by country and can take 1-2 days and as much as 10 days.

Customs and immigration requirements are established by the country of import and not by UniGroup Worldwide. This guide has been designed to assist clients understand and comply with country-specific requirements. Substantial effort has been made to ensure that the information provided is current and correct. Such regulations, however, are subject to change without notice by the country of import. UniGroup Worldwide assumes no liability for changes in the law or interpretation by enforcement personnel as it exists at the time you and/or your goods enter the country.

IMMIGRATION

When moving to Czech Republic, documents must be presented in the original or a notarized copy. Affidavits and legal documents issued and/or signed in Czech Republic must be notarized by a Czech Notary and documents must not be older than 180 days.

Visa	Requirements for EU/EEA Citizens and other nationals: • Passport • Applicant should provide an identity card which is valid for the entire duration of stay.
	Applicants of Bulgaria, Cyprus, Romania and Singapore are allowed to stay up to 30 days without visa.
	Applicants who are allowed to stay up to 90 days without visa are Andorra, Argentina, Australia, Bolivia, Brazil, Brunei, Darussalam, Bulgaria, Canada, Chile, Costa Rica, Croatia, Guatemala, Honduras, Hong Kong (special admin region of China), Israel, Japan, Macao (special admin region of China), Malaysia, Mexico, Monaco, New Zealand, Nicaragua, Panama, Paraguay, Republic of Korea, Romania, Salvador, San Marino, Singapore, Sovereign Military Order of Malta, Switzerland, The Vatican, Uruguay, USA, Venezuela.
Temporary Residency (up to 90 days)	Citizens of United Kingdom are allowed to stay up to 180 days without visa.

Details

- Applicant cannot travel to the Czech Republic with a Schengen Visa.
- No vaccination certificates are required unless the applicants are coming from an infected area.
- The visa office may always request additional documents and/or information before issuing the visa, therefore always include your home or office telephone number.
- In some cases the decision making process can take up to 30 days. The Embassy can not guarantee issuance of any visa. The decision is final and irrevocable.
- No visa can be obtained at the border or at the airports.
- The maximum length of an individual stay in the Czech Republic based on a visa is 90 days. The visa may be used at any time within 6 months from the date of issue.
- Bearers of Czech tourist visas must register at any Czech Immigration Police Station within 3 days after arrival in the Czech Republic. Visitors staying in hotels are registered automatically.
- There is no visa fee for children under 15 years of age.
- Visa processing time is approximately 90 days from the date the complete application is received and in the
 case of students the processing time will be 60 days. Particular complicated cases the procedure could take
 up to 180 days. Issuing a visa after the Embassy receives an approval of applicant's application from the
 Czech Immigration Police, then the applicant will have mail the passport again.
- Visa processing time for employee in the Czech Republic, the employee must obtain a visa even in case of period of stay not exceeding 90 days.
- Children who are under 15 years of age are provided visa of free of charge.





PERSONAL & HOUSEHOLD GOODS

Slovak laws are still being created and are expected to change. The proceeding information is a brief summary of customs regulations applicable to personal & household goods shipments to Czech Republic.

Required Documents	Details
Certificate of Free Entry	Shipper must obtain a Certificate of Free Entry from the Customs Head Office to insure that the shipment will be duty free.
Inventory List	Shipper should provide a detailed inventory list showing serial numbers and specifications of any electrical appliances. Inventory list must be dated and signed by the shipper.
_	Two sets of photos for any antiques and valuable paintings.
Passport	Shipper must provide a copy of valid passport.
Certificate of Registration	
Work Permit	For employment verification shipper must provide a copy of Work Permit.
Authorization Letter	Notarized authorization letter.
Letter by Employer	Shipper should obtain a Letter from employer on company letterhead verifying relocation with a guarantee of paying any customs duties on the importer's belongings in the case of non re-exportation.
Non-sale Certificate	Certificate of declaration that the shipper will not sell any items in the shipment.
Copy of Rental Contract	Rental period must be for a minimum of two years.
Power of Attorney	Attorney to authorize destination agent to represent the shipper with customs authorities.

Import Declaration Form	Import declaration form issued by the Embassy.
Czech Identity Card	Diplomats must provide a copy of Czech identity card with the residence address in the Czech Republic. If not available, must provide rental contract.

Household goods can be imported duty-free under the following conditions:

- Shipper can import personal & household goods duty-free, if the personal and household goods have been in shipper's possession and use for at least 6 months.
- Returning citizens of the Czech Republic can import personal & household goods duty-free, if the goods have been used by the shipper for at least 6 months prior to departure and the shipper must have been resided abroad for at least 12 consecutive months.
- Goods imported by the shipper must not be sold, rented or lent to another person during stay in country.
- Goods must be exported at the time set fourth during customs registration.
- In addition to the basic personal & household goods, the shipper may also import the following items dutyfree:
 - Arts and antiques
 - Indoor plants in reasonable quantities with the appropriate documentation
 - Domestic Animals with the appropriate documentation

Details

- Shipper must obtain a statement from the company vouching for the employee involved must be presented, for temporary or permanent residence due to company relocation.
- Shipper must provide photographs of all works of art for customs purposes.
- All documents must be in Slovak language.





MOTOR VEHICLES

Motor vehicles are considered personal effects, but a bank guarantee or security deposit is always required. Importation of motor vehicle into Czech Republic requires the following documents.

Motor Vehicles can be imported duty-free under the following condition:

• Shippers can import motor vehicles duty free who intends to re-export the vehicle within 6 months.

Details

- Before registration the motor vehicles must be inspected by the Technical Inspection Unit.
- Shipper must have used the motor vehicle for at least 6 months prior to shipping.
- The basic requirements for registration are a low emission rate, technical specifications of the vehicle and an
 operating manual. Special requirements for registration include side-view mirrors, lockable gasoline tank, lefthand drive, etc.

Required Documents	Details
Certificate of Health	
Veterinary Import Permit	Shipper must obtain an Import Permit for importing pets which is issued by the State Veterinary Administration of the Czech Republic.
Veterinary Certificate	Shipper must obtain a veterinary certificate from the state veterinary office in the animal's origin country.
International Vaccination	Applicant must obtain a certificate which is issued no more than 72 hours prior to
Certificate	the pet's departure.
Rabies Vaccination	Vaccination certified by veterinarian is required in case of dogs and cats.

Details

- The certificate must be in English, German, French, Russian, or Spanish.
- A rabies vaccination is must, at least 30 days prior to departure, in case of dogs and cats over three months of age.

RESTRICTED & PROHIBITED

All countries, including Czech Republic prohibit and restrict the importation of certain dangerous or sensitive items.

Prohibited Items

- Firearms and ammunition may only be imported after a gun license has been issued
- Weapons
- Drugs
- Fresh meat
- Pornographic material
- Non personal motor vehicles are prohibited

Restricted Items

- New items
- Foodstuff
- Commercial goods
- Alcohol
 - Wine: 2 liters per person maximumSpirits: 1 liter per person maximum
- Tobacco products
- Plants will need a FITO Certificate
